



Student Immunization Information

Students attending school in Ontario must provide proof of immunization as required by the *Immunization of School Pupils Act.* Students who are not immunized must provide a valid exemption. Ottawa Public Health must collect and maintain student immunization information. The information is reviewed each school year to ensure that students continue to meet the requirements of the law. If an exemption is required for any reason, contact Ottawa Public Health at 613-580-6744.
